Earnings Tax Department

Enclosed you will find the 2012 Reconciliation and 2013 Withholding Forms for money withheld from your employees' wages.

For submission of the 2012 Reconciliation and W-2 information, all employers with 50 or more employees are required to submit this information on a CD Disk instead of paper. Such requirement is part of our Tax Ordinance Rules and Regulations. Any employer with fewer than 50 employees is also welcome to do so. We need the same information you file with the Federal Government.

In an attempt to make your employer W2 reporting go a little smoother we would like to offer the following suggestions:

STEP ONE:

The Social Security Administration website offers a tool to be used by the person preparing the EFW2 file to test file's accuracy. This download can be accessed by going to: <http://www.ssa.gov/employer/accuwage/> and choosing the "Download AccuWage -2012 Tax Year" link. This link will download a setup file to the computer and, when executed, will install the Accuwage software on that machine.

This software will help the preparer determine if all the required elements are present in the file - with the exception of the "RS" record - which is the "extra" element required for a municipality's purposes. Please note, the "RS" record is defined by the Social Security Administration for use by municipalities - it is not something that we created.

STEP TWO:

The utility file available to allow the EFW2 preparer to test the RS record can be accessed by going to the City of Norwood's Software Vendor:

www.baldwingroup.com/W2verify.exe (the file is CASE SENSITIVE).

Again, this will download a setup file to the computer and, when executed, will install the Baldwin Group (MITS) W2 verification software on that machine.

The EFW2 files should be run through EACH one of those programs prior to the employer's submission to our office. The taxing entity code (positions 5-9) can be the first five letters of **Norwood**.

Please have your preparer download these files for their use in filing the W2's information more accurately and hopefully, with less frustration.
