Ordinance No. 17 20 20

ORDINANCE AUTHORIZING THE MAYOR OR SAFETY-SERVICE DIRECTOR TO ENTER INTO A LETTER AGREEMENT WITH THOMAS MCCABE TO SERVE AS FIRE CHIEF, CONSISTENT WITH THE TERMS OF THE ATTACHED EXHIBIT A, AND DECLARING AN EMERGENCY.


WHEREAS, Thomas McCabe began serving the City of Norwood as a Fire Fighter in 2000, has advanced to the rank of Assistant Fire Chief, tested highest on the Civil Service Examination for Fire Chief, and has accepted an offer of employment as Fire Chief, conditioned upon the Council approving that offer letter, dated March 20, 2020, by ordinance; now, therefore,

BE IT ORDAINED by the Council of the City of Norwood, State of Ohio, that:

SECTION 1. The Mayor or Safety-Service Director is hereby authorized to enter into a letter agreement with Thomas McCabe for his employment as Fire Chief, in accordance with the terms set out in the attached Exhibit A, made a part hereof by reference.


SECTION 2. This ordinance is hereby declared to be an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety and general welfare and shall go into effect forthwith. The reason for said emergency is the necessity to proceed forthwith in order to provide for a new Fire Chief and to incorporate the financial component of the Chief's employment terms in a new Financial Recovery Plan this month, as required by the fiscal emergency provisions of Ohio law.


